Producer's description

The Hochiki, Model CHQ-SOM, single output module provides for a single relay output to be connected to the ESP analogue addressable loop. The CHQ-SOM module incorporates a voltage-free relay contact that can be configured as either N/O or N/C. The CHQ-SOM module is fitted with colour-coded flying leads for connection to external devices, and also is provided with a wiring terminal block for loop connection.

The CHQ-SOM module must be fitted within either the SMB-1, SMB-2 or SMB-3 protective housings.
