## **Producer's description**

The Hochiki, CHQ-WS2 series, addressable wall sounder is a loop-powered wall sounder, which provides a range of tones and volumes.

All models can be mounted onto either the Hochiki Standard Base (YBN-R/3), Standard Base (red) (YBO-R/3(RED)) or Short-circuit Isolator Base (YBN-R/3(SCI)).

This device is Ingress Protection rated to IP33C when fitted with the WS2-WPK ancillary waterproofing kit.

The Hochiki, CHQ-WS2 series, addressable wall sounder is 110 mm diameter and has a height of approximately 80 mm when connected to the mounting base assembly.
