Producer's description

The Hochiki, Model SOC-AS3, photoelectric smoke detector uses a photoelectric sensing chamber to detect the presence of smoke. The detector has one light emitting diode (LED), mounted on the detector housing, which remains in the static off condition during normal operation. When the detector is in the alarm condition, the indicator is illuminated red (steady). The LED may also indicate a fault condition, by flashing once every 3 seconds, when contamination is identified by the drift compensation algorithm.

This device is 100 mm diameter and has a height of approximately 45 mm when connected to the mounting base assembly.
