### 1 Field of application

incite fire

The filter box small is used as an accessory part for aspirating smoke detectors SecuriRAS<sup>®</sup> in areas with **low temperature conditions** (below 0°C) and high dust levels to prevent false alarms and to increase the lifespan of the smoke sensors substantially.

The filter insert is designed for the separation of particles and impurities. Due their particle size, smoke particles can pass through this filter unhindered. Reliable and fast fire detection is thus ensured.

### 2 Construction

The filter box small is part of the suction pipe. The housing is made of polycarbonate, light grey paint (RAL 7035). The filter box can be opened using the 4 cover screws in order to clean the filter mat small for servicing work and to change it.

### 3 Function

The air polluted with dust particles is also aspirated by the aspirating smoke detector. To prevent false alarms, the aspirated air must be purified of these particles. The filter box small can be used for this purpose as an additional accessory component.

This is to be arranged directly in front of the evaluation unit in the suction pipe (see project planning notice). The aspirated air is conducted across the filter mat to filter the dust particles. If the filter mat is contaminated, it should be replaced during maintenance.

Advantages of the filter box small

- Prevention or substantial reduction of false alarms
- Lengthening of lifespan of smoke sensors
- Very low installation costs
- Subsequent installation possible at any time
- Low operating costs
- Applicable for all aspirating smoke detectors
- Quick, clean and inexpensive solution
- Field of application deep freeze area


### 4 Mounting

The filter box small must always be installed below the aspirating smoke detector to prevent false alarms due falling dust particles. If the formation of ice (at temperatures up to -30°C) can be expected at the suction openings, a wire connection unit WCU 535 should be installed in front of the filter box in accordance with the application guidelines for deep freeze stores (T 131 390D). Assembly and arrangement should be carried out in accordance with the project planning notice.

### 5 Maintenance and service

When carrying out maintenance work on the aspirating smoke detector, the filter mat should be replaced for the filter box "small", if necessary, and contamination within the filter box should be removed.

The Filter mat has to be placed with the mash side to the ASD and the fleece side in direction of the Suction line.

Furthermore, the technical documentation of the respective aspirating smoke detector must be considered.




Abb. 2 Standard installation





Abb. 3 Standard installation with wire connection unit WCU 535
